### CLASSIFICATION GUIDELINES:

**Original:** From the factory, **NOT RESTORED**.

**Restored:** A car that has been restored back to original using factory remanufactured parts with no more than 3 modifications - such as radio, safety belts, air cleaner, or other safety items.

**Street Machines:** Hot Rods, Street Rods, T-buckets, or open car with hi-performance engine, custom paint, chassis, wheels and tires, etc. **Not tubbed** with more extensive modifications.

**Modified:** Modified coupes or sedans with hi-performance engine, custom paint, chassis, wheels and tires, sound system, custom interior with more than six modifications.

**Pro-Street:** All vehicles with custom chassis, tubbed wheels, performance engine, custom paint, etc. (with/without roll bars).
